### **DECISION**

# 1. Introduction

This is an application by **Manunui Club Incorporated** for a special licence in regard to an event to be held at the Manunui Club situated at 14 Matai Street, Manunui. The nature of the event for which the licence is sought is the 'Annual Pig Hunting Competition'.

The date and hours sought are:

Saturday 10 August 2024

Interior: 2.00pm until 12.00am (midnight)

Exterior: 2.00pm until 7.00pm

### 2. Application

The application was received on the 4 July 2024 and included a site plan, flyer, manager's certificates and food list.

The application was not advertised and no objection or notice of desire to be heard has been received under section 141 of the Act. Accordingly we deal with the matter on the papers in accordance with section 202(1).

In considering the application for special licence the committee had regard to the following criteria under section 142 of the Act:

- (a) the object of this Act:
- (b) the nature of the particular event for which the licence is sought and, in particular,—
  - (i) whether the applicant is engaged in, or proposes at the event to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods; and
  - (ii) whether the applicant is engaged in, or proposes at the event to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:
- (c) the suitability of the applicant:
- (d) any relevant local alcohol policy:
- (e) whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of the licence:
- (f) the days on which and the hours during which the applicant proposes to sell alcohol:
- (q) the design and layout of the premises concerned:

- (h) whether the applicant has appropriate systems, staff and training to comply with the law:
- (i) any areas of the premises that the applicant proposes should be designated as restricted areas or supervised areas:
- (j) any steps the applicant proposes to take to ensure that the requirements of this Act in relation to the sale and supply of alcohol to prohibited persons are observed:
- (k) the applicant's proposals relating to—
  - (i) the sale and supply of non-alcoholic drinks and food; and
  - (ii) the sale and supply of low-alcohol drinks; and
  - (iii) the provision of help with or information about alternative forms of transport from the premises:
- (I) any matters dealt with in any report from the Police, the Medical Officer of Health, or an inspector made under section 141.

## 3. Reporting Agencies

The following reports were received under section 141 of the Act.

**Police Report** – No opposition within report received 8 July 2024.

**Medical Officer of Health** – No opposition within report received on 8 July 2024.

**Licensing Inspector Report** – Full report provided by the inspector including assessment of application against section 142 criteria. The Inspector concludes that the application is complete and will likely meet the criteria of the Act. The Inspector has no opposition to the issuing of the licence subject to the recommended conditions.

The inspectors report/file noted the following key matters –

- The applicant is a club who hold a club licence under the Act. The applicant has obtained a licence for this event previously and not come to the notice of enforcement agencies. The licence application is to allow persons attending the event to be on premises and consume alcohol when they are not a Club member.
- Approximately 150 people are expected to attend. The hunting competition will take place from Thursday 8 August to Saturday 10 August. This special licence application is made in respect to the weigh-in (from 2.00pm until 4.00pm) and prize giving (from 5.00pm onwards) element of the competition on Saturday 10 September 2023.
- Suitability is not challenged.
- The premises is to be located on the site at 14 Matai Street, Manunui on the premises known as the Manunui Club. The Club has a large bar area, dance floor and stage area shown as the lounge bar in the plans, which is where the prize giving will take place. The weigh-in will take place in a fully fenced outdoor area accessed via double doors from inside the Club. The applicant would like to include this area as in the past, some spectators have wandered out of the Club building to watch the weigh-in with a drink in their hand without realising. The outdoor area has been licensed since 2020 for this event, as shown on the site plan dated 30 January 2024.
- The whole of the licensed area is to be undesignated apart from smoking area which is restricted.
- The hours appear relevant for the event being undertaken.
- Three certified managers are nominated to be the responsible person to oversee the licence. This is supported.
- Both the Police and MOH have no opposition to the application

#### 4. Decision

The application for Special Licence is **Approved** for issue subject to the following conditions.

### 5. Conditions

**a)** Alcohol may only be sold under the licence to persons attending the Annual Tup Woods Memorial Pig Hunting Competition event on the following days and during the following hours:

Saturday 10 August 2024

Interior: 2.00pm until 12.00am (midnight)

Exterior: 2.00pm until 7.00pm

- **b)** Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application date stamped as received by the District Licensing Committee on 5 July 2024.
- c) The entire licensed area is undesignated apart from the smoking area which is restricted.
- **d)** A copy of this licence with all the conditions, must be clearly displayed in a prominent place so all persons can read it.
- **e)** Drinking water shall be freely available on the premises as specified in the application.
- **f)** The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- **g)** Food must be available for consumption on the premises as specified in the application.
- **h)** Low-alcohol beverages must be available for sale and supply on the premises as specified in the application.
- i) Non-alcoholic beverages must be available for sale and supply on the premises as specified in the application.
- **j)** The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application.
- **k)** The licensee must take the following steps to ensure that the provisions of this Act relating to the management of premises are observed:

That a certified manager must be present at all times during the event to oversee the licence, and

The duty manager's name must be prominently displayed inside the premises.
