DECISION

1. Introduction

This is an application by **Taumaranui Rugby and Sports Club Incorporated** for a special licence in regard to an event to be held at **Taumaranui Rugby and Sports Club** situated at 19/25 Cherry Grove Road, Taumarunui.

The licence is necessary to allow non club members attending the event to consume alcohol on the Club's premises.

The nature of the event for which the licence is sought is an 'end of season prize giving'. The date and hours sought are:

Saturday 10 August 2024 from 6.00pm until 1.00am the following day

2. Application

The application was received on 4 July 2024 and included manager's certificates, site plan, certificate of incorporation, booking of entertainer, associated emails and food list.

The application was not advertised and no objection or notice of desire to be heard has been received under section 141 of the Act. Accordingly, we deal with the matter on the papers in accordance with section 202(1).

In considering the application for special licence the committee had regard to the following criteria under section 142 of the Act:

- (a) the object of this Act:*
- (b) the nature of the particular event for which the licence is sought and, in particular,—*
 - (i) whether the applicant is engaged in, or proposes at the event to engage in, the sale of goods other than alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods; and*
 - (ii) whether the applicant is engaged in, or proposes at the event to engage in, the provision of services other than those directly related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services:*
- (c) the suitability of the applicant:*
- (d) any relevant local alcohol policy:*
- (e) whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, by more than a minor extent, by the effects of the issue of the licence:*
- (f) the days on which and the hours during which the applicant proposes to sell alcohol:*
- (g) the design and layout of the premises concerned:*
- (h) whether the applicant has appropriate systems, staff and training to comply with the law:*
- (i) any areas of the premises that the applicant proposes should be designated as restricted areas or supervised areas:*
- (j) any steps the applicant proposes to take to ensure that the requirements of this Act in relation to the sale and supply of alcohol to prohibited persons are observed:*
- (k) the applicant's proposals relating to—*
 - (i) the sale and supply of non-alcoholic drinks and food; and*
 - (ii) the sale and supply of low-alcohol drinks; and*
 - (iii) the provision of help with or information about alternative forms of transport from the premises:*
- (l) any matters dealt with in any report from the Police, the Medical Officer of Health, or an inspector made under section 141.*

3. Reporting Agencies

The following reports were received under section 141 of the Act.

Police Report – No opposition received within report dated 8 July 2024.

Medical Officer of Health – No opposition received within report dated 12 July 2024.

Licensing Inspector Report – Full report dated 15 April 2024, including assessment of application against section 142 criteria. The Inspector concludes that the application is complete and will likely meet the criteria of the Act. The Inspector has no opposition to the issuing of the licence subject to recommended conditions.

The inspectors report/file noted the following key matters –

- The event is expected to attract 90 attendees and includes prize giving followed by live entertainment.
- The applicant is a licensed club who require a special licence to allow non club members attending the event to consume alcohol at the Club. The Club has held similar events before with no known issues noted.
- Suitability is not challenged.
- The licensed area for the event is a large open plan room shown in the plan date stamped 17 May 2019.
- The hours appear relevant for the event being undertaken.
- Two certified managers are named to control the licence.
- Both the Police and MOH have no opposition to the application.

4. Decision

The application for Special Licence is **Approved** for issue subject to the conditions below.

5. Conditions

- (a) Alcohol may only be sold under the licence on the following days and during the following hours to persons attending the **'end of season prize giving event.'**
Saturday 10 August 2024 from 6.00pm until 1.00am the following day.
- (b) Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application date stamped as received by the District Licensing Committee on 17 May 2019.
- (c) A copy of this licence with all the conditions, must be clearly displayed in a prominent place so all persons can read it.
- (d) Drinking water shall be freely available on the premises as specified in the application.
- (e) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (f) Food must be available for consumption on the premises as specified in the application.
- (g) Low-alcohol beverages must be available for sale and supply on the premises as specified in the application.
- (h) Non-alcoholic beverages must be available for sale and supply on the premises as specified in the application.
- (i) The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application.

- (j) No BYO alcohol allowed on the site.
- (k) The licensee must take the following steps to ensure that the provisions of this Act relating to the management of premises are observed:
 - That a certified duty manager be present at all times the license is in operation, and
 - The duty manager's name must be prominently displayed inside the premises.
